

# LTC Code and Claim Form Conversion: LTC Accommodation Code to Revenue Code, Value Code and Value Code Amount Crosswalk

In 2023, the Department of Health Care Services (DHCS) will replace the use of Long Term Care (LTC) local Accommodation Codes with a combination of National Uniform Billing Committee (NUBC) Revenue Codes, Value Codes, and Value Code Amounts for LTC services.

The intent of this crosswalk is to illustrate the relationship between the local Accommodation Codes and the comparable NUBC codes.

## Notable Revenue Code, Value Code and Value Code Amount Differences

The single local Accommodation Code will be replaced by three NUBC billing codes: Revenue Code, Value Code 24 (Medicaid Rate Code) and Value Code 24 Amounts (Designated State Level Medicaid Rate Code). Due to slight differences between the *UB-04* claim form and electronic 837I transaction, the *UB-04* and 837I Value Code 24 Amount (Designated State Level Medicaid Rate Code) data entry format has been added for reference. Refer to the forthcoming *UB-04* and 837I billing instructions for detailed information on how to use these data elements to bill for LTC services.

Local Accommodation Codes 01, 02, and 03 currently represent either Distinct Part or Free-standing LTC facilities. After the code conversion, these two different facility types will each have their own unique Revenue Code, Value Code 24 (Medicaid Rate Code), and Value Code 24 Amount (Designated State Level Medicaid Rate Code) combinations.

Similarly, local Accommodation Codes 41 and 43 currently represent LTC facilities that have either 1 to 59 beds or 60 or more beds. After the code conversion, these two different facility types will each have their own unique Revenue Code, Value Code 24 (Medicaid Rate Code), and Value Code 24 Amount (Designated State Level Medicaid Rate Code) combinations.
