

**Effective November 1, 2018: CHDP Phase 3 HIPAA Code Conversion – School-Based Services Crosswalk**

The national codes in this crosswalk are effective for dates of service on or after November 1, 2018.

**IMPORTANT:** Providers may wish to save this chart as a reference for phased out local codes.

Providers should disregard the earlier July and September 2018 versions of this chart.
