

Multipurpose Senior Services Program (MSSP) Code Conversion – Policy Effective January 1, 2024

Effective for dates of service on or after January 1, 2024, the MSSP code conversion will replace non-Health Insurance Portability and Accountability Act (HIPAA)-compliant Healthcare Common Procedure Coding System (HCPCS) Level III codes, commonly referred to as local codes, with HIPAA-compliant HCPCS Level II national codes. Below is a crosswalk of the non-HIPAA-compliant codes to the HIPAA-compliant code sets.
